I INTRODUCTION

Smokehalt V smoke curtains/shutters are uniquely made in our own ISO9001 accredited facility using only high quality components. The system consists of a head box, side guides, bottom bar and curtain barrel. With a head box size of just 165mm x 165mm the Smokehalt V smoke curtain is capable of spanning up to 9m without overlaps and multiple modules, significantly reducing the ceiling cavity space required of overlapped systems.

I COMPLIANCE

Smokehalt V smoke curtain complies with National Construction Code Specification E2.2b Smoke Reservoirs

Smokehalt V also complies with EN12101.1 Smoke Curtains and can be used with and without side guides for all ratings inclusive of D30 through to DH120.

The Smokehalt V system has also been tested in accordance with AS1530.7 Air (smoke) Leakage as a smoke containment screen.

Smokehalt V also bears the Warnock Hersey Mark. The Warnock Hersey Mark (WH) signifies that our manufacturing sites undergo periodic and independent 3rd party inspections to ensure ongoing compliance with fire test approvals. The WH Mark is the world largest product compliance scheme and provides our customers with total surety by eliminating product and component substitution. The system supplied has been constructed and complies in full with our fire test approvals.



Smoke Control is the only manufacturer and supplier of fire & smoke curtains whose products have been accredited under this scheme outside of the USA, providing many customers around the world, total assurance in our company and products.

I FUNCTION

SYSTEM OPERATION

The system is typically in the open position during normal building use. On receipt of an alarm or power outage, Smokehalt V smoke curtains deploy to provide fire and smoke compartmentation. On reset of the Fire Indicator Panel, the system automatically rewinds back into the standby position.

The control box is a compact 250 x 200 x 75mm deep box requiring a standard 240V, 10A power supply and an alarm signal in the form of a normally closed dry contact. A localised smoke or heat detector may also be used to activate the system.

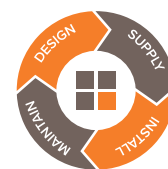

EGRESS

When Smokehalt V smoke curtains are used as part of the egress strategy, rewind switches can be connected directly to the standard control box. The switches can be mounted on one or both sides of the wall. Once pressed the system will retract and then redeploy. The retraction is based on a timer. This timer can be set to open the curtain to a minimum height before redeployment. The rewind system is supplied standard with a battery back up for operation during mains power failure.

INSTALLATION

In line with Smoke Control's mission to provide customers with reliable solutions, the Smokehalt V system is installed by our fully trained and approved installer network.



MAINTENANCE

As with all essential services Smokehalt V should be maintained in strict accordance with our documented procedures by fully trained and competent technicians. Operational tests alone are not considered adequate and when conducted by inexperienced personnel, may lead to damage of the product. Smoke Control offers a comprehensive preventative maintenance program which has proven costs savings over the life of the product.

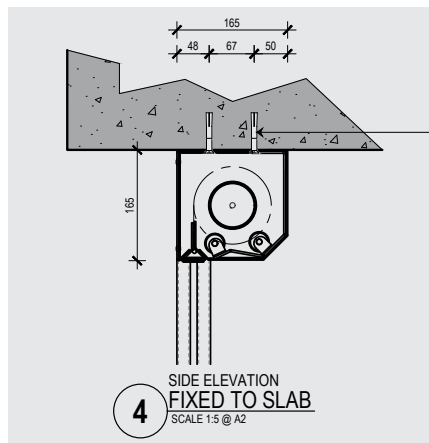

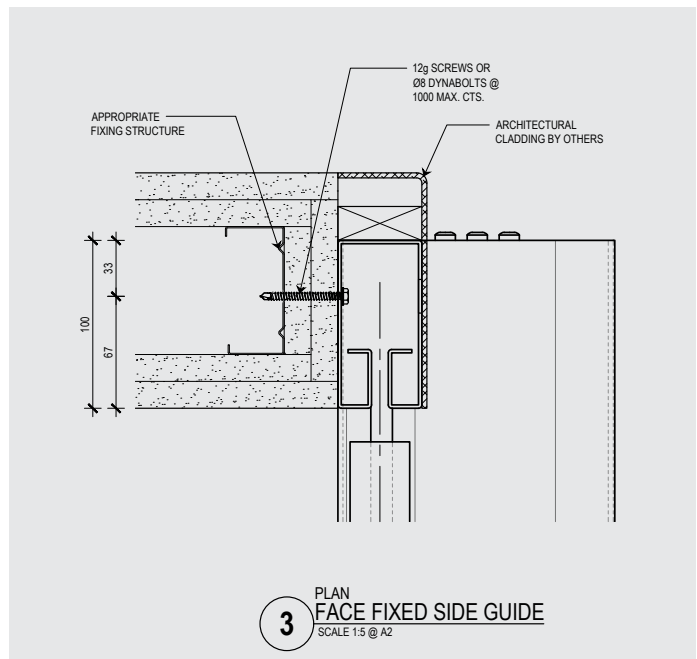
Atrium Smoke Baffles used in conjunction with smoke venting/exhaust systems
